

UV 5 YEAR LIMITED WARRANTY



Water Gem, Inc. guarantees to the original owner that the new Ultraviolet Disinfection System manufactured by us under Model # _____ bearing Serial # _____ and installed on _____ (date) is free from defect in materials and workmanship.

*****Please Note: All products must be registered with Water Gem, Inc. for warranties to be valid. Please fill out and mail the enclosed warranty card within (30) days from date of installation to place your ultraviolet disinfection system in warranty. Please retain this copy for your records. Water Gem retains the right to request documentation for install date verification*****

How does my warranty work?

If, during the respective warranty period, a part proves, after inspection by Water Gem to be defective, Water Gem will, at their sole option repair or replace that part at no charge, other than normal shipping, installation or service charges.

What is covered by the 5 year limited warranty?

Water Gem guarantees to the original owner the stainless steel disinfection chamber, of the above serial numbered system, not to leak, burst or fail in any way for a period of five years from the date of original installation.

What is covered by the 1 year limited warranty?

Our obligation under this warranty, with respect to the electrical components, will be limited to one year warranty. Electrical components will be limited to replacement for or at our option prorating any part or parts which to our satisfaction prove defective within one year from the date of original installation.

The terms and provisions of the above warranty are subject to the conditions covered in the installation manual.

The labor charges incidental to the repair and/or replacement of parts, electrical components, or ultraviolet disinfection system other than factory repairs is expressly excluded from this warranty.

How do I obtain warranty service?

Should you need service, your local independent Water Gem dealer is only a phone call away! To obtain warranty service, notice must be given, within 30 days of the discovery of the defect, to your Water Gem dealer. General Provisions

The above warranties are effective provided the Ultraviolet Disinfection System is operated at water pressures not exceeding 125 psi and at water temperatures not exceeding 105°F; provided that the Ultraviolet Disinfection System is not subject to abuse, misuse, alteration, neglect, freezing, accident or negligence; and provided further that the Ultraviolet Disinfection System is not damaged as the result of any unusual force of nature such as, but not limited to flood, hurricane, tornado or earthquake. Water Gem is excused if failure to perform its warranty obligations is the result of strikes, government regulation, materials shortages or other circumstances beyond its control. Installation must be made in accordance with legal or local codes and manufactures recommendations.

THERE ARE NO WARRANTIES ON THE ULTRAVIOLET DISINFECTION SYSTEM BEYOND THOSE SPECIFICALLY DESCRIBED ABOVE. ALL IMPLIED WARRANTIES, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE, ARE DISCLAIMED TO THE EXTENT THEY MIGHT EXTEND BEYOND THE ABOVE PERIODS. THE SOLE OBLIGATION OF WATER GEM UNDER THESE WARRANTIES IS TO REPLACE OR REPAIR THE COMPONENT OR PART WHICH PROVES TO BE DEFECTIVE WITHIN THE SPECIFIED TIME PERIOD AND WATER GEM IS NOT LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES. NO WATER GEM DEALER, AGENT, REPRESENTATIVE OR OTHER PERSON IS AUTHORIZED TO EXTEND OR EXPAND THE WARRANTIES EXPRESSLY DESCRIBED ABOVE.
